### Review of Political Activities

The objective of the Party is to expose fraud, corruption and other criminal activities at local and national level, and to seek justice for anyone suffering as a result. This also involves exposing negligence by the regulatory authorities such as the police.

In the year ending 31 March 2012 the party entered candidates in the elections and by-elections at several parishes within the district of East Hampshire and in four of the wards in East Hampshire District Council. The Party also entered a candidate in the by-election for the Headley Divi

The Party intends to enter candidates in any parliamentary by-election which may take place in or near Hampshire prior to 31 March 2013. The Party also intends to enter a candidate in the election of Police Commissioner for Hampshire in November 2012

The Party continues to make strong representation on behalf of people who are oppressed or who are exploited by those in central or local government and to support and nominate candidates at local and national elections
