## Overview of political activities

The local party fought council and European elections that took place in May 2014; continued to support the sitting MP for Twickenham, Vince Cable; and made preparations for the general election in Twickenham with Vince Cable MP as the prospective parliamentary candidate and in Richmond Park, with Robin Meltzer.

## **Branches**

The local party area contains the whole of Twickenham constituency and around two thirds of Richmond Park. The party campaigns in Parliamentary elections through separate Twickenham and Richmond Park operations with separate bank accounts and Treasurers. Expenses for all activity in Richmond upon Thames are included in these accounts.

Twickenham & Richmond Liberal Democrats has 11 branches, and their income and expenditure is included in these accounts. Five are in Richmond Park constituency and are: Barnes, Mortlake and East Sheen; Ham Petersham and Richmond Riverside; Kew; North Richmond; and South Richmond. There are six branches in Twickenham constituency, namely: Fulwell and Hampton Hill; Hampton and Hampton North; St Margaret's, North Twickenham and Twickenham Riverside; South Twickenham; Teddington and Hampton Wick; Whitton, Heathfield and West Twickenham.
