Review of The Party's Political Activities' during period 1<sup>st</sup> January 2015 to 31<sup>st</sup> December 2015.

### Overview.

With no electoral contests during this period we concentrated our collective efforts around the following issues;

- Recruitment.
- Education.
- Finance
- Continued development and implementation of a 5 year strategy to oversee the Party's Policies and agreed position moving forward.
- Public profile and awareness of Party's Policies and history.
- Exploring possible partnerships with like minded socialist groups.
- Monthly meetings of the Irish Republican Socialist Party were held in the following areas; Belfast, Crumlin Co.Antrim, North Antrim, Derry City, South Down, South/ North Derry, and Strabane.

The Irish Republican Socialist Party was active on the ground in relation to a wide range of campaigns such as;

- ➤ National Campaign against cuts in Public Services; attending many meetings and rallies, as well as seeking to form partnership/alliances based around these campaigns with various like-minded groups.
- ➤ Working with local homeliness charities' in Belfast.
- ➤ Working with local Families to help them resolve communal tensions in areas throughout the North.
- > The Party produced and rolled out a programme of Education for its membership through out the above named areas. This took

form by way of Political lectures at both National and Branch levels. [on-going]

- As with previous year the Party released numerous press releases and statements to the media on a wide range of topics.
- ➤ Working in a positive way at various inter-face areas helping to reach a compromise between both effected communities.
- ➤ Working with Youth in various areas on-going, looking at raising their political and cultural awareness, addressing issues around sectarianism, racism, etc. [On-Going]

During this reporting period Party Members travelled to Europe to meet with like-minded groups and to promote, forge links and advance the Politics' of the Irish Republican Socialist Party. This was a very worthwhile and beneficial event for all involved and we hope to attend similar events in the future.

Branch meetings are held across all areas mentioned in this report and meet on either a weekly or monthly basis to discuss and debate not only party policy, but to also deal with matters regarding on-going strategy and its implementation as well as organizational issues

In conclusion, from the 1<sup>st</sup> of January 2015 through to the 31<sup>st</sup> of December 2015 the Irish Republican Socialist Party continued to push its own brand of policies/Politics, and remains committed to overseeing the growth of the Party throughout the coming year. This has been successful and we have witnessed a slight growth in our membership; recruitment continues to be a priority for us as a Party and is on-going.
