2017 was a year of success for the Aldershot & North Hants Conservative Association.

The County Council elections took place on 4th May. The Association fielded candidates in all six of the divisions that we have responsibility for. The Conservatives gained Farnborough West from UKIP and Aldershot South from Labour whilst holding onto the Farnborough North, Farnborough South and Aldershot North divisions. Our success on 4th May helped the Conservatives to increase their overall majority in Hampshire.

Following the resignation of Peter Moyle, a by-election was held in St John's ward. Jonathan Canty comfortably held the seat for the Conservatives with an increased majority.

Mid way through the county council elections Theresa May called a snap general election for 8th June. Two days later Sir Gerald Howarth announced that he would not be contesting the election.

The Association chose Leo Docherty to be their candidate at the general election. Campaigning for the general election took part in all parts of the constituency. Members of the Aldershot & North Hants Association were also able to provide support and mutual aid to our colleagues in Brentford and Isleworth constituency in West London.

Leo Docherty retained the Aldershot seat for the Conservatives with a majority of 11518.

Since the general election the Association has held a number of CPF discussion events. Branches have been busy campaigning, canvassing and delivering In Touch newsletters. Candidate selection for the 2018 local elections is at an advanced stage.

Financial Activities

Income overview

Income from all sources increased significantly compared to the previous year.

Most significant were large donations received to support Leo Docherty's campaign in the general election but membership subscriptions and fund raising all showed healthy increases reflecting much hard work done by

association supporters. Also very much appreciated were personal contributions made by councillors towards the running costs of the Association office, an initiative begun in 2016 and continued this year. A special mention is deserved for the CWO group who managed to increase their fund-raising results versus the previous year despite several of its key members suffering ill-health.

Expenditure overview

Expenditure was increased only slightly versus the prior year which was an outstanding effort considering that we had to fund both County Council elections in May and an unexpected General Election in June. Running costs for the office were reduced again from the previous year despite the additional election workload.

A significant surplus achieved this year has strengthened the balance sheet and allowed us to build a substantial fighting fund to support future election campaigns.
