REVIEW OF POLITICAL ACTIVITIES

Overview

The primary focus of activity this year as in previous years has been the local Borough Election campaign. We have ensured good levels of fundraising and encouraged donations in order to fight a successful campaign.

We retained our seats and gained a further five. The Chorley Borough Council is currently made up of 37 Labour, 8 Conservative, 1 Independent and 1 seat remains vacant.

The surprise General Election in December resulted in further donations to our MP, Sir Lindsay Hoyle's Campaign Account. However with his success at being elected Speaker and subsequently having to resign from the Labour Party all funds for that purpose were moved from the Chorley CLP Campaign Account to his Independent Speaker Campaign Account.

Membership

The membership consists of full members who live in the constituency and organisations entitled to pay affiliations under national party rules. The membership rose from 854 to just over 900. This reflected a national trend where membership saw a temporary drop in numbers and then began to improve.

The Chorley CLP has 7 branches under its control, along with an affiliated branch of Young Labour. The branches are: Adlington and Anderton, Astley and Euxton, Canal, Chorley Rural North, Clayton, Coppull and Chisnall, Park. All income received and expenditure incurred by all branches are included in the Statement of Accounts attached.



The CLP Executive Committee meets regularly on a monthly basis throughout the year (except during election periods). They manage the business of the Chorley CLP. During the year a number of All Members Meetings have been held to discuss topics involving local and national issues.

Delegates from the CLP attended the Labour Party National, Regional and Women's Conferences.

REVIEW OF FINANCIAL ACTIVITIES

Income increased from £14,235.14 in 2018 to £22,153.34 in 2019. This increase reflects the increase in fundraising particularly for Local and General Election funds.

Membership income dipped slightly from a record high in 2018

Expenditure also rose from £13,558.02 in 2018 to £26,219.14 in 2019. This increase emphasised the expected campaign costs in the Local Election, but particularly the high costs of a General Election Campaign. As explained in the Overview, as a result of our MP being elected speaker, the amount of £7,583.00 was moved out of the Chorley CLP Account to the Speakers own Campaign Account.

There has been a decrease in the net assets held by Chorley CLP as would be expected following the closure of the General Election Campaign Account and the transfer of funds to the Independent MP's Speaker Account. However this would have occurred had the funds been used in a normal General Election campaign. We must continue to work hard at fundraising and encourage donations for all future campaigns despite the loss of our MP from the Labour Party.
