### **REVIEW OF POLITICAL ACTIVITIES**

### Overview

The main campaigning activities in 2019 was the General Election, and elections in Kidlington for the Cherwell District Council seats.

### Membership

Membership across Oxford and District retained the high levels achieved during the previous two years, with an additional growth in members after the December 2019 General Election.



#### REVIEW OF FINANCIAL ACTIVITIES

### Income

In addition to our regular fundraising from members and from our two major Labour Groups, Oxford and District Labour Party held two events primarily to generate funds. The election period generating a significant total of one-off donations from a wide range of members and affiliated bodies.

### Expenditure

The main elements of expenditure remain office rental and associated office costs, the employment of a paid organiser and the costs of materials for campaigning during the election periods.

#### Assets

The only asset owned by Oxford and District Labour Party is an income generating life assurance policy, which varies in value in line with the relevant investments.
