Overview

Review of Political Activities

WR membership has grown by 40% over the year. Wessex being a large region, it has not always been easy for members to attend meetings so platforms like Zoom have proven to be a great way to widen participation. The regular quarterly Executive Council meetings in person were cancelled but the weekly Zoom review meetings, introduced in 2020, have proven to be an even better way of making progress on updating the Party's messages and image. It is so effective that it is likely to become part of our established way of working even once all Covid problems have become history. Mostly through our Secretary-General's internet skills, we have increased our presence on social media using Facebook and Twitter and the on-line Members' Forum. Working collaboratively the Executive Council have achieved more updated and published policy papers, background papers, blog posts, and more use of social media. More is in production so that we have more and more examples to show the people of Wessex what their regional government could provide.

Our President continues to gain experience of how local government works in his position as vice-chair of a parish council. He has successfully pushed colleagues on that council to take responsibility for local measures, most significantly a Climate Action programme, based on WR's own platform.

The aim for the next 12 months is to continue to increase the use of social media and the evolving manifesto to raise the profile of the Party as a credible alternative to the mainstream parties.
