Overview of political activities

2022 was a quiet year from an activities perspective as many people were not comfortable socialising whilst there were still outbreaks of Covid-19. Later in the year activities picked up. Nevertheless, the requisite Executive Council and Management meetings were held, where possible in person.

There has been considerable feedback from members regarding the behaviour of the party during the year, with an initial surge in membership after Boris Johnson resigned, followed by a deep drop in recent months when the members were effectively excluded from the leadership selection process.

There were 5 Basingstoke and Deane Wards up for election during the year, 2 of which were lost to the Lib Dems. We also had a Test Valley By-election in December, also lost to the Lib

Dems.

The discussions regarding the boundary commission's recommendations also generated severe negative feedback, with many members questioning how, following a building boom across the constituency, the Commission still uses data from 2012 to define boundaries. The move of several wards to Romsey has not been well received. We are now seeing a significant exodus of members in the affected wards, who owe their loyalty to this Association and our MP.
