### Three Rivers Liberal Democrats Accounts for the Year Ended 31st December 2024

#### Income Overview

Income was predominantly from donations. Additional General Election funding of £10,000 was provided by the East of England Regional Party and £2,300 by the West Herts Local Party in respect of the Kings Langley part of South West Herts constituency.

#### **Expenditure Overview**

Expenditure included approximately £37,000 on non-election campaigning and £55,400 on campaigning during election regulated periods.

#### **Balance Sheet Overview**

Expenses exceeded income by over £2,100 in 2024. Funds of £5,321 were carried forward to 2025.

#### Overview of political activities

Following parliamentary boundary changes, the Three Rivers Liberal Democrats Local Party came into effect on 1 January 2024, covering the entire electoral area of Three Rivers District and all of the revised South West Herts constituency with the exception of Kings Langley. Campaigning activities were focussed on the local elections on 2nd May, followed by the General Election on 4th July. There were also a number of district and parish by-elections.
