Significant increase in membership subs (+ £1,200 compared to 2023). Significant increase in donations (+ £12,100 compared to 2023). £6,200 raised in national / local fundraising.

Significant increase in branch spending (+ £4,400), including £12,000 of donations paid to the CLP for election materials.

Significant increase in campaign spending (+ £14,200) covering General Election and preparation for the local elections. Increase in office costs to include purchase of high-speed laser printer.

Overall surplus for the year of £5,298.
